

Dear Friends.

On behalf of the Code of Support Foundation (COSF), we are proud to share with you this report of our efforts to meet the unique challenges of 2020 in continued service to our active-duty, veterans, caregivers, and their families. In spite of the challenges, COSF made great strides in what was a challenging year for both the veteran community and the nation.

When the Covid-19 pandemic reached the US, the impacts were immediately felt in our military and veteran communities. COSF responded guickly, deploying our team to address the truly devastating effects, which are still impacting the country today. Our front-line Case Coordination services experienced a 200% increase in requests for support almost overnight, while searches for emergency resources on PATRIOTlink.org increased exponentially. 2020 was a year of uncertainty and instability for many of our nation's veteran families, with spikes in need for access to food, transportation and employment, paying bills and securing affordable housing, and providing reliable, remote mental health and caregiver support. In the face of these unprecedented challenges. COSF doubled-down on our commitment to stand with those who stood for our country.

As often is the case for our military and veteran families, COSF also turned opposition into opportunity. What was once an in-person office is now a 100% remote workforce. Now, our team is located throughout the country and is able to provide both local and national resources virtually, online, by phone, and by video conference. We are proud that in 2020, Code of Support staff have served more veterans and military families than any other year to date. Like those we serve, we will not be deterred by obstacles in our fight to ensure every military and veteran family receives the support they have earned through their service and sacrifice.

2021 marks 10 years and thousands of families served by the Code of Support Foundation. We are humbled to celebrate this milestone, even as we continue to see the rippling effects of 2020. It's because of you that we are able to do this important work. Thank you to all of our generous partners, funders, and donors. It truly is an honor to have served our veteran community for the last decade — with your support, we look forward to the next 10 years.






Changing Lives One Click at a Time

2020 Growth

PATRIOTlink's most significant period of growth was in 2020 when it was featured in the VA newsletter and 6,000 new users registered on the site, with an additional 3,000 users registering through the remainder of the year.

In 2021, COSF has built on the platform's momentum and entered into a collaboration with Google for a new partnership to expand reach. The goal of the partnership is to get PATRIOTlink in front of every veteran and service member's family so that they can quickly and easily find the support they need. This is an ambitious goal, but we believe that it is realistic—especially in light of the VA's endorsement and current use of PATRIOTlink. The COSF team is already seeing a marked increase in new users in states with high veteran populations, such as California and Texas.

Easier Connections for a Full Range of Needs

COSF's team firmly believes that PATRIOTlink is the solution for connecting veterans and service members to fully-vetted and free resources, both locally and nationally.

The PATRIOTlink team added over 2,000 resources specific to pandemicrelated needs like food insecurity and peer support.

In honor of Veterans Day, Google launched their "Serving Veterans" initiative to promote mental health awareness, and included PATRIOTlink on the Google homepage.


New Look

Archer's 100 Mile Challenge

Glenn Archer (COSF board member, ultraathlete and Air Force Veteran) recognized the importance of maintaining physical and mental health during the Covid-19 pandemic. Thus, Code of Support's first build-your-own-race virtual event launched — Archer's 100 Mile Challenge.

Athletes committed to completing 100 miles in 30 days by any means necessary, all while promoting the mission of COSF. In its inaugural year, 23 athletes conquered the challenge and we look forward to expansion in 2021.



2020 TOTAL REVENUE


2020 EXPENSES

Covid-19 relief loans helped Code of Support like many other nonprofits across the country. Currently, the staff is seeing an uptick in fundraising activity, and those loans have fully qualified for conversion into grants.

Long-term, staff is committed to continuing a trend of increasing program spending over the next three to five years. It is expected that this investment will broaden the appeal to potential funders, and the team is actively engaged in diversifying its funding portfolio to take advantage of giving trends. Aggressive work is also being done to implement additional program metrics, to be able to demonstrate why an investment in better outcomes for veterans through Code of Support is money well spent.
