WELCOME

Dear Friends,

After 10 years of service, we are proud to release this report of our ongoing service and commitment to our troops, veterans, caregivers, and their families. After the previous year's unprecedented challenges, we reached new milestones of service for those who have defended our country. The needs of our constituents and the ongoing impacts of COVID-19 required our case managers and PATRIOTlink[®] teams to keep pace. Our team rose to meet the need, supporting more military and veteran families than ever before. The Code of Support Foundation (COSF) continues to pursue its mission — to ensure all those who serve receive the resources they need and have earned.

Throughout 2021, COSF responded to an increasing demand for housing, food, mental health support, and financial assistance. As the world emerges from the pandemic, many of those we serve were challenged by increased housing costs, supply chain shortages, shifts in the employment market, and gaps in available services. The needs were particularly great with families, where challenges often come rapidly as both children and parents cope with new stressors. These trends continue as more military and veteran families face homelessness and food insecurity.

Through your support, we have increased access to PATRIOTlink, our no-cost and verified resource directory, and expanded our case management function to provide assistance for those with the most complex needs. Overall, we have served more military and veteran families than ever before — keeping families in their homes, ensuring bills are paid and food is on the table.

Over the past two years, the COSF team diversified in both skills and capabilities while also shifting to a fully virtual nationwide staffing model. We rapidly augmented PATRIOTlink through new and verified resources and removed the login requirement to allow easier access. Case Coordination has focused efforts and training to support at-risk communities, and has made additions to our referral and partner networks in areas with the greatest need. We have added new and valuable experiences to the team through a nationwide workforce that are primarily veterans, caregivers, and military spouses.

The Code of Support Foundation celebrated 10 years of service in 2021, thanks to your dedication to our military and veteran communities. We are grateful for your continued trust and support of our mission, and we stand ready to meet the needs of our constituents. Through your support, we will continue to bring hope and assistance to the military and veteran families we serve.

With gratitude for our incredible partners, funders, and donors represented in this report — it's because of you that we are able to change and save lives.





★ Easier Access


The PATRIOTlink team removed the sign-up requirement to enable more users to access resources without disclosing personal information to afford more privacy for searches.


★ Better Searches

Archer's 100 Mile Challenge celebrated its second anniversary! Inspired by COSF board member and Air Force Veteran Glenn Archer, the Challenge adopted a virtual format last year during the COVID-19 pandemic.

Two years on, the virtual race still inspires participants to compete and raise awareness for military and veteran families in need. In 2021, 14 competitors completed 100 miles in 30 days, raising over \$11,000 in support of veterans and families.

FINANCIALS


